(£11.00 each). It is required by the Inland Revenue that you state your first forename in full. Thank you very much for your co-operation.

GIFT AID NOTES

1. You must pay an amount of income tax at least equal to the tax that the Charity "Plymouth U3A" reclaims on your donations in the tax year (currently 28p for each £1 you give).
2. You can cancel this declaration at any time by notifying the Charity "Plymouth U3A".
3. If in the future your circumstances change, and you no longer pay tax on your income and Capital Gains equal to the tax that the Charity reclaims, you can cancel your declaration (See Note1).
4. If you pay tax at the higher rate you can claim further tax relief in your self - assessment tax return.
5. If you are unsure whether your donations qualify for Gift Aid relief, ask the Charity "Plymouth U3A" Treasurer, or ask your local tax office for leaflet IR65.
6. Please notify the charity "Plymouth U3A" if you change your name and address.
